Description of first aid measures	
Eye Contact	▶ If in eyes, hold eyelids apart and flush the eye continuously with running water. ▶ Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. ▶ Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. ▶ Seek medical attention without delay; if pain persists or recurs seek medical attention. ▶ Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.
Skin Contact	If skin or hair contact occurs: ▶ Flush skin and hair with running water (and soap if available). ▶ Seek medical attention in event of irritation.

PETROLATUM	Dermal (rabbit) TDLo: 100 ml/kg/30D-I Tumorigenic effects. "Hydrocarbon wax" describes a group of solid C20 to C36 paraffinic hydrocarbons which are not absorbed in the gastro-intestinal tract and in small quantity will pass through undigested. Refined waxes are used widely in cosmetic surgery over many years and this demonstrates their low toxicity; many guidelines exist for their safe use. However, occasionally there are reports of adverse effects with these products. Deposits under the skin, referred to as "paraffinoma" have been described, but these are not normally associated with other progressive changes. Long-term toxicity studies indicated that petroleum-derived paraffin and microcrystalline waxes are non-toxic and do not cause cancer.
